I have received your instructions and have sent the file according to your instructions. **PLEASE NOTE THE EMAIL CHANGE.** I had requested and been told that my e-mail address has been changed to ac.ekin@gmail.com or ac.ekin@keptlight.com . I got this message at cemal.ekin@cox.net which can be terminated by my old provider any time. As luck would have it, it is still working but not guaranteed to work in the future.

One point I do not understand is the image dimension being 20" on the long edge. Clearly that is far too large for the book that will be published. Are there plans to use it for other venues? If so, what kind?

My image will not be that large, around 2400x3000 pixels. That is almost the full size of the original capture. I presume it will be more than large enough for the book.

The file name: EKIN_A Cemal_USA_Mina.jpg (Note that my name has a first initial A as in A. Cemal Ekin)

I had submitted two images sequentially numbered and the second one was juried in. In this submission, I have removed the sequential numbering from the title, I hope that is not a problem. The title was "Mina-2" I am submitting the large file with the title "Mina" without a number.

You have my permission to use this photograph in the 2nd edition of the PORTRAIT & PEOPLE. If possible, I would like to receive an acknowledgment of this message and that my e-mail address has been corrected.

The Book "Portrait & People" will be published 2 weeks after receiving the high resolution files we're requesting in this email. It will be published in hard cover versions, and will contain your name and image title next to your work.

In case you wish to be published we need from you a couple of things:

1. A written confirmation (sent by email to publishing@thegalaawards.com) that you agree to publish your work. No need to send a signed agreement; an email is sufficient.

2. High resolution files of your work according to the following specifications:

- Resolution: 300 dpi
- Size: 20 inches in the largest side (if 20" is not available, the largest possible size up to 20 inches)
- Profile: RGB
- File extension: jpg (please do not send tiff files)
- Compression quality: 12 (high)

When sending your work, please rename the files according to the following format (please note where to use capital letters and the use of commas or underscores):

YOUR LAST NAME, Your full first name, Your country, Image Title.jpg. or
YOUR LAST NAME_Your full first name_Your country_Image title.jpg

Example: SMITH, John, USA, Sunset.jpg or SMITH_John_USA_Sinset.jpg

The work we're asking you to send us in high resolution files is the one featured in <http://www.thegalaawards.net/announcements/2nd-edition-portraits-a-people>.

The high resolution files have to be sent using our You Send It's Dropbox (<https://dropbox.yousendit.com/SENDTOWPGA>) before October 21th. After that date we won't be able to feature your work in the book due to the layout and printing schedule. If you have any trouble to send your files by the requested date please email support@thegalaawards.com to let us know.

Being featured in the Book "Portrait & People" has no cost for you, and the purchase of the book will be absolutely optional. Once the book is ready we will email you to keep you posted. The book will be available for preview in the Books section of our site (you may currently preview the book of the first edition of the Portraits and People Contest in <http://www.thegalaawards.net/store>, as well as other books published by WPGA)
